# Important Terms & Conditions of this Licence

Please ensure that you understand your responsibilities regarding the following:

### 1. Drunk and disorderly behaviour and supply of illegal drugs

The Hirer shall ensure that in order to avoid disturbing neighbours to the Garron Centre and avoid violent or criminal behaviour, care shall be taken to avoid excessive consumption of alcohol. Drunk and disorderly behaviour shall not be permitted either on the premises or in the immediate vicinity.

Alcohol shall not be served to any person suspected of being drunk or to any person suspected of being under the age of 18. Any person suspected of being drunk, under the influence of drugs or who is behaving in a violent or disorderly manner shall be asked to leave the premises. No illegal drugs may be brought into the premises.

## 2. 'Challenge 25' Age Verification

Any person appearing to be under the age of 25 years must be asked to produce identification showing a photograph and date of birth to prove they are over eighteen years old. Suitable documents include a photo identification card, driving licence, or a proof of age card bearing a hologram.

#### 3. Noise

The Hirer shall ensure that the minimum of noise is made upon arrival and departure, particularly late at night or early in the morning. The Hirer shall, if using sound amplification equipment, limit the amount of noise made and comply with any other licensing condition for the premises.
